OPERATION OF THRIFT SHOP TO RAISE FUNDS FOR INOVA ALEXANDRIA HOSPITAL. TOTAL SALES FOR THE CURRENT YEAR WERE \$425,565 WITH COST OF GOODS SOLD OF \$425,565. COST OF GOODS SOLD CONSISTS OF CONTRIBUTED INVENTORY.

THE SHOP ALSO PROVIDES A PLACE FOR THE COMMUNITY TO DONATE, RATHER THAN DISCARD, UNWANTED ITEMS, AND A PLACE FOR THE COMMUNITY TO BUY DISCOUNTED ITEMS AT AN AFFORDABLE PRICE. CLOTHING AND HOUSEHOLD ITEMS ARE ALSO PROVIDED FOR NEEDY RECIPIENTS DESIGNATED BY LOCAL CHURCHES THROUGH A CLOTHING VOUCHER PROGRAM. THERE ARE APPROXIMATELY 2,500 CUSTOMERS AND DONORS.
